<u>Overview</u>: The updated Exhibit 1, Scope of Use (E300) has been updated to reflect minor changes due to clarification of definitions, updated Product names, new Products and update restrictions to the use of ArcGIS Online Data and Online Services.

Addendum 1; Section 1- Definitions

What: Concurrent Use License and Deployment Server License Definitions (pg. 1 of 16)

Why: Definitions were updated to clarify meaning.

"Concurrent Use License" means a license to install and use the Product on computer(s) on a network, but the number of simultaneous users may not exceed the number of licenses acquired., including. A Concurrent Use License includes the right to run passive failover instances of Concurrent Use License management software in a separate operating system environment for temporary failover support.

"Deployment Server License" means a full use license that authorizes Licensee to install and use the Software for the following purposes: building and testing Value-Added Applications; conducting user acceptance testing, performance testing, and load testing of other third party software; staging new commercial data updates; training activities; and all other all uses permitted in the License Agreement and as described in the Documentation.

<u>Why</u>: Esri removed the requirement that the user purchased an ArcGIS Online Subscription in order to use non Esri developer tools to build applications that use Esri's Online Services. Users of an ArcGIS Online Plan may still use the developer tools to build applications that consume online services, but there is still the requirement to acknowledge that the application is using Online Services and Users may not remove any attribution associated with the use of Online Services.
